Professional Development

We'll be spreading the word about GFOA Alberta at RMAA and SUMA in Saskatoon this spring, and we can't wait to connect with even more people in the region.

A quick note on budget 2025, there were two points that caught my eye:

- Increase in grants made to municipalities in lieu of property taxes on government owned property to 75%, up from the current 50%. By next year the province will cover 100% of the amount that would be paid if the property was taxable.
- \$820 million this year and \$2.5 billion over 3 years in Local Government Fiscal Framework capital funding to help fund local infrastructure projects.

Also, something I can appreciate is the new 8% personal income tax bracket for income under \$60,000 starting in 2025.

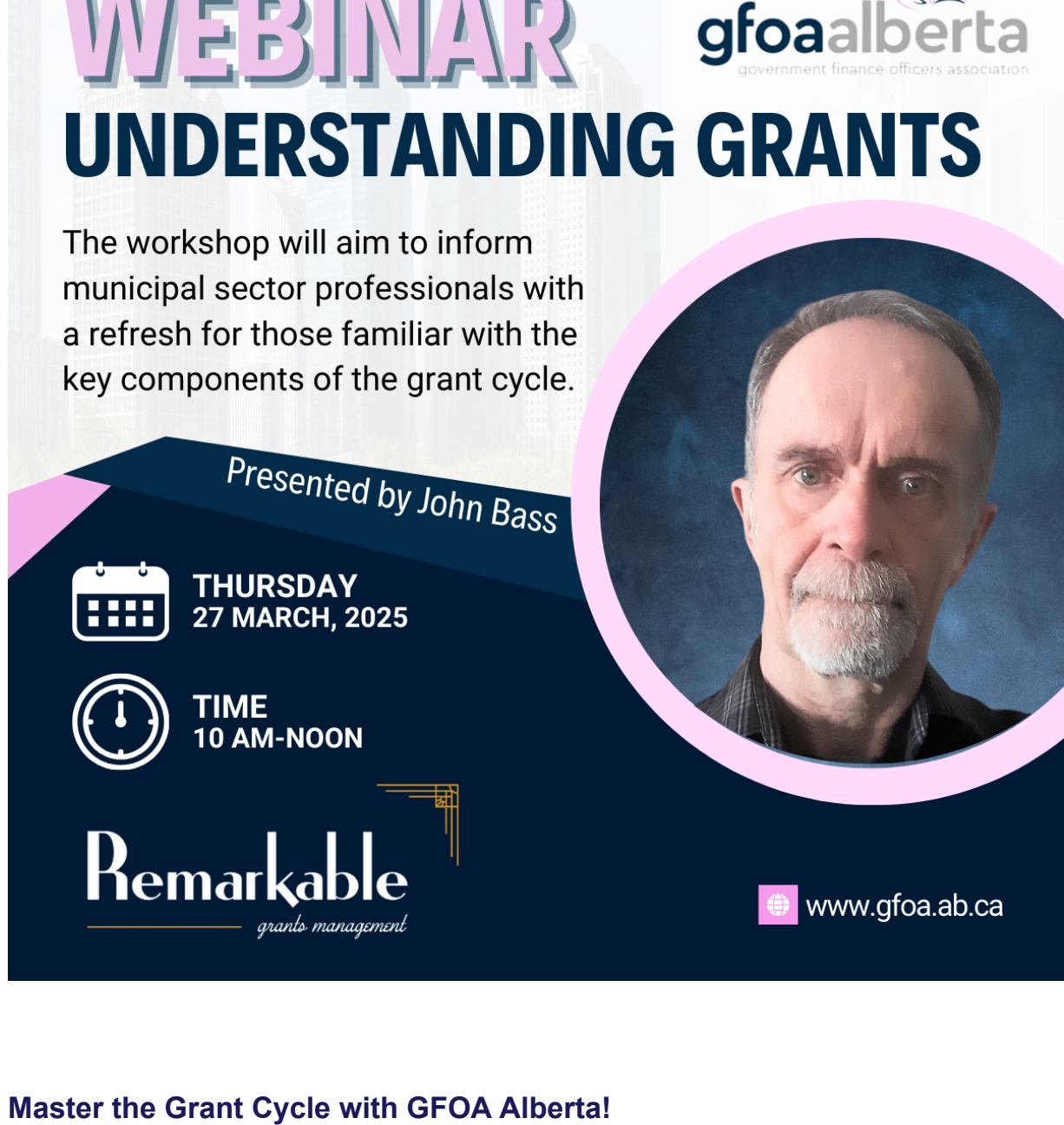
