### **Request for Comments**

Alberta Municipal Affairs is seeking comments on the merging of the Financial Information Return (FIR) and the Statistical Information Return (SIR). The main implication is that the SIR would be filed in May rather than July. Take a look at the proposal and contact Municipal Affairs at the email indicated in their request if you have comments or concerns.

As Municipal Affairs begins this transition, they are seeking feedback on the following items regarding the existing statistical information:

- 1. Can it easily be "audited" and as such may be "transferred" into the Financial Information Return without adding significant costs to the municipality and/or auditor,
- 2. what lines may already exist as a data point within another easily accessible/verifiable dataset,
- 3. What, if any, additional lines should be added/removed/altered to the unaudited schedule, and
- 4. Where should "Schedule ST" be placed within the template (first schedule seen or last schedule)

Municipal Affairs has heard that in some cases the FIR takes time to complete. As part of this review, Municipal Affairs is interested in hearing about solutions where/how this process can be automated, and if auditors have any experience in other jurisdictions where this process has automated.
